**2.** In the reference 3<sup>rd</sup> cited, Sri V. Jeevan Kumar Reddy, AEE/ South/Tirupathi was represented that, he was a Direct Recruit of former DISCOM i.e., APCPDCL (Now TSSPDCL) 2004 batch. Sri K. Naga Prasad and Smt. N. Sarada, AEEs/El. Juniors to him in the APCPDCL. He was transferred to APSPDCL and joined in APSPDCL on 05.06.2007. As per AP Re-Organization Act, 2014 both of them were transferred to APSPDCL and in the provisional seniority list issued vide reference 2<sup>nd</sup> cited, Sri K. Naga Prasad (Sl. No. 11) and Smt. N. Sarada, AEEs/El. (Sl. No. 12) were placed above Sri V. Jeevan Kumar Reddy, AEE/El. (Sl. No. 14) which is objectionable and requested for rectification of seniority.

**3.** After careful examination, it is observed that, Sri V. Jeevan Kumar Reddy, AE/El. was appointed as AE on contract basis and regularized his services at former APCPDCL w.e.f. 01.12.2006 and the name of Sri K. Naga Prasad and Smt. N. Sarada, AEs were kept below Sri V. Jeevan Kumar, as they were absorbed in former APCPDCL from other DISCOMs on request transfer. Accordingly, the revised provisional seniority is communicated to the effected individuals.

**4.** The individuals are requested to submit their objections within 7 days from the date of receipt of the Revised Provisional Seniority list through their representation along with proof of evidences to examine and to finalize the seniority.
