The Government of A.P. introduced a policy on Net metering for Solar grid interactive Rooftop and Small power plants in the State vide references 2nd to 4th cited to make use of unutilized places wastelands, rooftops of individual house holds, commercial complexes, institutions etc., by adopting Net metering facility to convert huge potential of solar radiation into solar electricity generation, mainly for the use of self consumption and to feed excess energy in to grid at the pooled cost decided by Hon'ble APERC year on year.

Considering the above policy, it is to inform that the GoAP vide reference 1st cited has clarified that the term small SPV power plants referred to in the solar net metering policy shall mean SPV power plants up to a capacity of 500 KW as covered under the subsidy scheme of Government of India.

In this regard, the undersigned is directed by APPCC to inform as to the aforesaid clarification for consideration in adopting AP Solar net metering policy to have solar capacity addition in the sector.

Further, it is also requested to place the aforesaid GoAP clarification in official websites of DISCOMs for information among consumers and prospective SPV sources in the region.

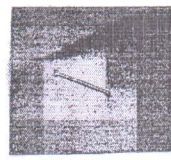

Government of Andhra Pradesh vide reference 1st cited have introduced a policy for encouraging Net metering for solar grid interactive roof-top and small SPV Power Plants.

2. Vide reference 2nd cited, Government of Andhra Pradesh have made a provision for payment for excess energy injected in to the grid at pooled cost as decided by the Hon'ble APERC in respect of these Solar grid interactive roof-top and small SPV power plants.

3. In this regard, it is clarified that the term small SPV power plants referred to in the references cited shall mean SPV power plants up to a capacity of 500 KW as covered under the subsidy scheme of Government of India.
